### Beach/Grounds

- 1. Review agreement for Seasonal Employment & Gatehouse/Maintenance-reviewed
- 2. Condition of benches, picnic tables, and grills-some benches and the beach picnic table are beyond repair, therefore, Karen will investigate options and pricing for new benches and beach picnic table and report back to commission.
- 3. Bark mulch for playground-discussion about needing bark mulch for playground and idea of getting it delivered on a regular schedule. Lions Club has agreed to come work on the playground once the mulch is delivered.

## Camp 3 Ponds

- 1. Review agreement for Seasonal Employment & Wages for Camp 3 Ponds-Current Camp employee wages were reviewed and discussed. Wages from nearby towns and cities were used for comparison to current Camp employees. All commission members were in agreement with needing to increase Camp employees' rate of pay. Motion made by Chris Jacobs for Karen to gather revenues from the past five years and give suggestions on potential wage increases and the impact on the budget. Second by Humphrey Williams. Motions carried.
- 2. Container gardens for the beach for Camp 3 Ponds have arrived.
- 3. Perkins Concrete-the signed contract has been sent and we are on the schedule for spring.
- 4. Canopy update-the building has been ordered from Versa Tube Building Systems.

Motion made by Chris Jacobs for Karen to file the "Intent to Apply" Land and Water Conservation Fund local assistance program for the dock and launch. Second by Sarah Rogers. Motion carried.
