**Vouchers ~**

***1988 Daniel and Geneva Lockhart Fund***

A voucher was submitted by Jill Palmisano in the amount of \$87.56 for beautification done to the Lockhart Memorial Fairy House & Garden. The funds to come from the *1988 Daniel and Geneva Lockhart Fund* with a check being mailed to 340 Bolan Road, Milton, NH 03851. All necessary documents were presented to approve

***2011 Education of Special Needs Children***

A voucher was submitted by the Milton School District on 12/28/2023 in the amount of \$48,000 to reimburse the Milton School District for the purchase of a Wheel Chair Bus for Special Needs Children. Based on a letter we received from the schools Attorney we will approve the \$48,000 however noting the Milton School District would not provide documentation backing up the inclusion of the transportation being part of an IEP. The funds to come from the *2011 Education of Special Needs Children* with a check being mailed to the Milton School District @ SAU 64 Office.

- Karen Brown motioned to approve this voucher, seconded by Marion Trafton. Motion passed 3-0.

***2011 Education of Special Needs Children***

A voucher was submitted by the Milton School District in the amount of \$25,551 to reimburse the Milton School District for the purchase of a new wheel chair lift to replace an old wheel chair lift at Nute High School. The trustees unanimously agreed that it was the schools obligation under ADA Law they need to have a working lift to accommodate everyones needs and not just the special ed students needs. The trustees agree that the appropriate fund should be the *2005 School Bldg Maintenance & Repair Fund* (\$207,558.42) if the school chooses to move forward with this voucher.

***2005 School Bldg Maintenance & Repair Fund***

A voucher was submitted by the Milton School District in the amount of \$8,260 to reimburse the Milton School District for the purchase of replacing 2 steel doors at Milton Elementary School. The funds to come from the *2005 School Bldg Maintenance & Repair Fund* with a check being mailed to the Milton School District @ SAU 64 Office.

- Karen Brown motioned to approve this voucher, seconded by Marion Trafton. Motion passed 3-0.
