<u>Police Department:</u> Line 120 Salary PT was reduced by \$6,000.00 leaving a line total of \$6,000.00. Bottom line \$953,806.00.

<u>Treasurer Budget:</u> Line 130 Salary Elected was reduced by \$114.92 leaving a line total of \$6,760.00. Line 220 FICA was reduced by \$6.87 leaving a line total of \$426.00. Line 225 Medicare was reduced by \$1.24 leaving a line total of \$100.00. The remainder of the budget was tabled until the Treasurer can attend to answer questions.

Planning Board Budget: Leave as is. Bottom line \$1,250.00.

Planning/Code Department: Leave as is. Bottom line \$87,885.00.

Zoning Board of Adjustment Budget: Leave as is. Bottom line \$1,085.00.

<u>Conservation Commission Budget:</u> Line 320 Legal Defense was reduced by \$2,500.00 leaving a line total of \$2,500.00. Line 395 Professional Services was reduced by \$5,000.00 leaving a line total of \$1,700.00. Bottom line \$6,600.00.

Economic Development Committee Budget: Leave as is. Bottom line \$3,500.00.

Budget Committee Budget: Leave as is. Bottom line \$1,890.00.

Welfare Department: Leave as is. Bottom line \$123,650.00.

Moderator Budget: Leave as is. Bottom line \$7,309.00.

Sewer Department: Leave as is. Bottom line \$84,072.00.

Assessing Department: Leave as is. Bottom line \$128,109.00.

<u>Contingency and Bonding Budget:</u> Line 899 Miscellaneous was reduced by \$2,000.00 leaving a line total of \$15,000.00. Bottom line \$61,911.00.

<u>Fire Department:</u> Leave as is. Bottom line \$412,698.22.

Emergency Management Budget: Leave as is. Bottom line \$4,308.00.

Outside Appropriations Budget: Consensus to level fund at 2015 levels with the exception of line 352 Sexual Assault Support Services (SASS) which will be a combination of 352 SASS and 363 A Safe Place as those two organizations have merged. Line 350 Strafford CAP at \$7,250.00. Line 351 Homemakers Health Services at \$1,839.00. Line 352 A Safe Place/SASS at \$825.00. Line 353 Aids Response Seacoast at \$400.00. Line 354 Cornerstone VNA at \$4,598.00. Line 355 Youth Sponsorships at \$1,500.00. Line 361 at \$900.00. Line 362 American Red Cross at \$325.00. Line 364 CASA at \$325.00. Line 366 Coast Bus Services at \$325.00. Bottom line \$18,287.00.

<u>Town Administration Budget:</u> Line 320 Legal Services was reduced by \$3,000.00 leaving a line total of \$37,000.00. Line 391 Legal Notices and Ads was reduced by \$2,500.00 leaving a line total of \$7,047.00. Bottom line \$270,297.00.
