## Town of Milton Board of Selectmen Special Meeting May 4, 2019 Milton Town Hall—Town Administrator's Room

**Board of Selectmen Attendance:** Chairman Ryan Thibeault, Vice-Chair Erin Hutchings, Member Andy Rawson.

Staff and Others Attendance: Interim Town Administrator David Owen, Ernest Creveling

Public Attendance: None

R. Thibeault convened the meeting at 9:20 AM in the Town Administrator's Office at Town Hall with all members in attendance. The purpose of this special meeting was for the Selectmen to approve and sign the employment agreement with the new Town Administrator, Ernest Creveling. It was moved by Ryan Thibeault, and seconded by E. Hutchings, to approve and sign the employment agreement with Ernest Creveling for him to serve as the Town's new Town Administrator beginning May 15, 2019. The motion was approved by unanimous vote and the parties proceeded to sign two copies of the employment agreement.

It was then moved by Andy Rawson, and seconded by Erin Hutchings to recess the meeting until the beginning of the auction of tax-deeded properties downstairs at 10:00 and to continue the meeting downstairs at 10 AM. Ryan Thibeault announced that he will be recusing himself from the continuation of the meeting during the auction as he may be bidding on the properties. The motion to recess and continue the meeting downstairs was approved unanimously.

The meeting was reconvened at the beginning of the public auction at 10 AM in the basement of the Town Hall. The Board approved Sale #1, the property at 1121 White Mountain Highway (Tax Map 22, Lot 19) for \$11,000, with both Selectman Hutchings and Rawson voting aye. The Board also approved Sale #2, the property at 16 Spruce Lane (Tax Map 9, Lot 2) for \$39,000, with both Selectman Hutchings and Selectman Rawson voting affirmatively.

The public auction of tax-deeded properties was concluded at 10:32 AM, after which the Board of Selectmen signed the Purchase and Sales agreements with the winning bidders. However, in the case of Sale #7, after a dispute arose between the winning bidder and an abutter to the property, the Board agreed to allow the winner bidder to withdraw his bid. The meeting adjourned at 10:45 AM.
