Milton School District Total Budget for 2016-2017 is \$9,944,178.56 Offset by Grant of \$441,704. The Budget increase is \$309,453.

The School Board voted to recommend the budget Total of \$9,939,178.56 the vote was (4-1) an increase of \$304,453.
