## MILTON CEMETERY RULES AND REGULATIONS

Upon acceptance of this document, Grantee acknowledges that specific Rules and Regulations apply:

- 1. No improvements or alterations of any individual lots are allowed.
- 2. All in-ground planting <u>of any kind</u> including shrubs, plants, trees or flowers (including artificial) is prohibited on individual lots and will be removed, as will dead flowers that have not been picked up.
- 3. The placing of boxes, shells, toys, metal, balloons, designs, ornaments, chairs, settees, loose stones, vases, and similar articles upon plots will not be permitted and if so placed, the management reserves the right to remove them.
- 4. Glass containers are prohibited.
- 5. Solar or battery powered lights are prohibited.
- 6. Spring clean-up will begin by April 1<sup>st</sup> at which time all decorations must be off the lots. Fall clean-up will begin by October 1<sup>st</sup> and flowers of all types, urns, and pots. Winter decorations may be placed on lots after November 15<sup>th</sup>. Flags will be placed on Veteran's graves by appropriate organizations for Memorial Day. One small personal flag is allowed to be placed in the ground next to the base from Memorial Day through Flag Day on June 14<sup>th</sup> only. Following that, they will be removed unless they are in metal flag holders or placed inside a flower container or urns. No urn or container may be used for placement of a flag only.
- 7. The Milton Cemetery Trustees will have charge of the location of all monuments and markers.
- 8. All single graves or any block of graves, three or less, shall have only granite or stone markers flush with the surface of the ground for identification.
- 9. Four, six and twelve grave lots may have monuments and be placed, as approved by the Trustees, with a cement base.
- 10. Any grave or graves wishing to be sold by a lot owner must be sold through the Milton Cemetery Trustees at the price at which it was purchased.
- 11. These Rules & Regulations or certified copy, will be provided to the lot buyer with the Right to Inter Document.
- 12. All interments must be made at the direction of the Milton Cemetery Trustees:
  - a) Layout for grave digger
  - b) Monitor opening and closing all graves
  - c) Insure that all documents for record keeping of birth and death dates have been submitted
- 13. State of New Hampshire Permit forms will be the responsibility of the Milton Cemetery Trustees:
  - a) Burial permits
  - b) Transfer permits
- 14. All vault burials must be conducted under the supervision of a licensed undertaker and must follow all laws and regulations of the state.
- 15. A single lot may contain one full vault burial plus a maximum of two cremations; OR four cremations only.
- 16. The Milton Mills Cemetery tomb is available at no charge for temporary storage of remains from December 1<sup>st</sup> through June 1<sup>st</sup> for owners for right to inter only.
- 17. These Rules and Regulations will be posted conspicuously at the cemeteries.
- 18. These Rules and Regulations are subject to change at any time by the Board of Trustees.
