III. Letter of support to DES for SELT Szirbik Project. Steve had supplied a draft letter of support, requested by SELT for their ARM grant application for the 540-acre Szirbik project along the Jones Brook, which CC members had had the opportunity to review before the meeting. There was brief discussion, all mentioning how significant this project is and agreed that the CC would consider helping fund it if asked. Bob moved to approve the SELT ARM grant support letter. Wayne 2nded. All in favor.

IV. New CC Officers -- Chair and Vice Chair Steve declined since he is treasurer. Deb declined, doesn't want that job. Wayne declined; he serves as TPPA liaison and has enough to do at TPPA. In fact, he is willing to be an alternate if someone is found who wants to be another full member. Bob declined because is overwhelmed and pondering if he wants to renew his CC term next spring.
