**Proposed Zoning Amendment Public Hearing for 2021 Town Meeting**

The Milton Planning Board will meet on **Tuesday, January 5, 2021\* at 6:30 PM at Milton Town Hall** to hold a Public Hearing as described below:

**Hearings – Zoning Amendment for Town Meeting**

1. **Adding language creating a Solar Facilities Ordinance** - This proposal will amend the Zoning Ordinance by adding a new Article XXII, that establishes a Solar Facilities Ordinance that will accommodate solar energy collection systems and distributed generation resources in appropriate locations throughout Town, while protecting the public’s health, safety, and welfare. The ordinance facilitates the State and National goals of developing clean, safe, renewable energy resources in accordance with the enumerated polices of NH RSA 374-G and 362-F that include national security and economic and environmental sustainability. The draft solar collection system ordinance will be enacted in accordance with NH RSA 674:17(I)(j) and the purposes outlined in NH RSA 672:1-III-a as amended.
