- 9 Virginia Long, Chair, opened the public session at 6:00PM.

- 11 1.) Ascertain who is present and approve alternates to serve as full members if needed.
- 12 2.) Welcome to guests in attendance
- 13 3.) Discussion with Bruce Woodruff regarding Town of Milton Master Plan and MCC's role implementing 14 the plan and its priorities: Bruce was invited to attend the meeting to provide discussion and direction 15 regarding the Master Plan, especially in areas where the Conservation Commission is involved. These 16 include surface and groundwater resources, wetlands, wildlife and habitat, agricultural, etc. Deb – 17 question on Page 22 regarding protection of surface water. How does the new Article 3 on Split Zoning 18 impact the protection of water? Bruce – this will eliminate split zone parcels and will not have any 19 impact as the regulations do not change. There is a stringent approval process and will still be in effect. 20 Jeff – stressed the importance of education on septic system maintenance. Bruce – there are town 21 initiatives happening including flyers and pamphlets that provide education to residents. This is required 22 for the MS4 permit. It's important to inform and educate residents on the best practices and what 23 techniques are available for residents in order to protect their lands. Although we are in Year 3 of the 24 MS4, the town is slightly behind it its implementation. As explained, MS4 affects Milton since waters 25 from Milton flow down into Great Bay. Virginia – there is a lot of overlap between MS4 and the Master 26 Plan. Jeff had previously volunteered to draft a letter to homeowners providing education about septic 27 systems use – perhaps this could be used as part of resident outreach. Virginia – the CC is looking to 28 prioritize the implementation plan. Bruce – suggestion to have the Commission host an education 29 outreach program. Wayne – the TPPA new website will also include many resources and information. 30 Steve – is there any budget available for outreach endeavors? Bruce – there may be some grant 31 opportunities available in May (but currently no budget). Steve - since there is not enough time to solicit 32 grants any upcoming programs will be low budget.
- 33 Bruce – page 54: Zoning Ordinance – Milton Wetlands Map – suggestion to bring to the table for meeting 34 with selected partners. Additional layers will be added to the GIS to help in the decision making process. 35 Bruce will be talking to all departments, including CC to collect all ideas from department heads. He will 36 then start to prioritize and work with GIS consultant to concentrate on those most important. Steve – 37 what teeth does the town have to enforce policies to ensure residents following the rules? Bruce – stringent regulations for new developments include legally binding documents that require 38 39 builders/homeowners demonstrate their obligation to follow all regs. For example, the town can hold a 40 compliance hearing to go before the planning board which has the power to revoke the plan. Steve what about existing home owners? Bruce – the Code Enforcement Officer really has the power to do this 41 42 although this is not currently a FT position to handle all the issues. It would be better if the CC had access to the Code Enforcement Officer. Virginia – discussion about potential designation of 'Prime Wetlands.' 43
- 44 Bruce recommendation to have CC educate the Planning Board about this before submitting a Warrant

61		3/2/2022 minutes: Steve – motion to approve the 3/2/2022 minutes with Virginia's corrections (sent
62		out in advance). Seconded by Wayne. All were in favor; the motion was approved.

64 CF	8.)	Schedule Public Hearings for Conservation Fund donations to MMRG conservation projects:
65 66		At a recent meeting there was a vote to expend \$5,000 from the Conservation Fund (CF) to MMRG for
66 67		each of two projects. As required, a public hearing is needed when expending monies from CF. June 1 st meeting will include a public hearing to start at 6:00PM. As there are two separate projects, two
68		separate hearings will be held. They are already posted on the town website. In addition, when donating
69		to projects the CC is also required to notify the BOS before expending funds. Virginia will attend an
70		upcoming BOS meeting about the plan to hold hearings and expend funds.
71	9.)	Review/Report on Wetlands and Shoreland Applications:
72	5.7	Jellystone Park – wetlands field report by Gale Associates: according to the report, Jellystone has 'lived
73		up to the spirit' and has met the necessary requirements.
74		Wetland buffer zone violation (basal area law) on Winding Road (suggest town hire PT Timber Harvest
75		Monitor): At Lyman Brook, Virginia saw there had been a lot of cutting done in the area. As she thought
76		this was a violation, she asked Jonathan Nute to also look which he did and he agreed this could be in
77		violation. Virginia then contacted the state who went to the area and agreed the slash is in violation,
78		however the basal area is not.
79		She suggested the town hire a part-time Timber Harvest Monitor who could check on potential
80		violations. This was be discussed more at a future meeting.
81	10.)	Town-owned Easements and Conservation Lands:
82		Easements: Update on letters to landowners of town-held easement properties and their responses
83		(Spring Brook, Tremblay / Wallace Way parcel donation?): ~30 letters were sent to town-held easement
84		properties. So far there have been two responses:
85		Gary Tremblay (Wallace Way) – he is no longer a town resident and indicated he may want to donate the
86		land to the town. This is ~5 acres off Governors Road. There is no public access – ROW for the developer
87		and the land owners on Wallace Way). Questions: associated closing costs – who is responsible for
88		paying?; 2.) Landowners abutting this land have access, however, there is no public access to the land.
89		Wayne – there is no real advantage to pursue this as it's not really connected to any land of interest.

90		Virginia will tell Mr. Tremblay the CC is not interested in pursuing.
91		Walt Cheney, Sr. – interest in parcel 'Old Ski Area': Virginia – Mr. Cheney recently attended BOS meeting
92		and expressed his interest in purchasing the parcel known as 'Old Ski area'. Virginia reached out to Chris
93		Jacobs and Walter Cheney telling them this is conservation land which neither of them were aware of.
94		Virginia – important to educate all town officials about town conservation lands and easements. Steve –
95		this information should be in the GIS. 2010 – town voted to place a conservation easement on this
96		property but never happened. MMRG might be interested in helping conserve this land (year 2023). This
97		will be kept on the agenda.
98		Karen – suggest having this as a Warrant Article removing the requirement of a town easement? Virginia
99		– we could do that, but do we really want to sell the property? Maybe a site walk is in order. Steve –
100		since the town already voted on this, we should move forward with it. Could take grant money to add
101		two easements and start the process with MMRG. A possible ARM grant (for restoration purposes). Site
102		walk scheduled on April 24 th at 9:00AM – meet in the Dollar General parking lot. Will have to invite the
102		public.
103		Regarding site walks of CC properties: for the first time should hold these site walks as a group. Wayne –
104		the CC could save \$1,000 by doing site walks instead of paying Chris Kane. Virginia - ~20% of our budget
105		is used to pay Mr. Kane. Wayne – if the CC does the site walk and sees a violation, what happens?

107		Virginia – report back to the CC and we can decide what would be the next course of action. Wayne –
		question why the CC would assume responsibility of monitoring? Virginia – it's important to do the site
109		walks and see what, if any, violations are happening.

127		 lots of legalese language which might turn people away from volunteering. Virginia – the Charge
128		provides information on the policies set forth by the town. Deb – because this is a new committee they
129		may need additional guidance especially in the beginning. Virginia – we want them to be independent –
130		they can reach out to the CC for support and guidance. Karen Golab – maybe call it the 'Milton Trails
131		Support Group' in order not to fall under all the rules. However, volunteers will still need to complete a
132		volunteer form required by the town. Virginia – the CC will help recruit. However this will still need to be
133		approved by the BOS.

143		Virginia – because the town had voted to place an easement on the property not sure this would work as
144		the CC just can't give away the land. Question about Mr. Cheney's plans and interest for the property.
145		There are too many complications involved with this. After discussion, Mr. Cheney withdrew his initial
146		idea. Steve – the ski area would be even worse project than the 45 acres he is currently proposing. It
147		would be very difficult to develop and not have severe drainage issues.
